WHAT IS THIS PRODUCT?

Type

This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (SICAV).

Term

This product has no maturity date. However, the manufacturer may decide to close the product under certain circumstances.

Objectives

Using a dynamic asset allocation strategy among multiple fixed income sectors, the Sub-Fund seeks high current income and capital appreciation as a secondary objective. The Sub-Fund can use several hedging tools to reduce the volatility. The Sub-Fund will invest mainly in bonds and Money Market Instrument of any type of corporate and government issuers world-wide located and in other similar debt securities, including treasury bills and treasury bonds. The Sub-Fund may invest:

- up to 20% in convertible bonds; contingent convertible bonds; unrated securities with a credit rating of B- or higher
- up to 10% in debt securities issued by rated issuers with a rating of CCC or less; for the sake of clarity, investments in defaulted securities are not envisaged nor allowed

The Investment Manager shall not seek to invest directly into equity securities. However, by way of exception and with reference to subordinated bonds and convertible bonds, such debt instruments may be converted into equity securities under some conditions. In such a case, the Sub-Fund may remain invested in such equity instruments up to 10%. Using macro-economic analysis, the Sub-Fund will switch from High Yields to investment grade or sovereign bonds or bonds issued by sovereign national agencies, to adapt the risk profile to the current economic phase. So, for the avoidance of doubt, the Sub-Fund can have an exposure up to 100% in High Yield or investment grade securities. The Sub-Fund shall not

invest more than 10% in other UCITS and/or UCIs. The Sub-Fund may also enter into derivative contracts both for hedging as well as for investment purposes. The derivatives used will include but will not be limited to forwards, futures, plain-vanilla options, listed options on high yields ETFs, credit default swap ("CDS"). The Sub-Fund may invest in TRS and CDS on single name, basket of names and credit indices (such as the ITRAXX and CDX indices) composed in compliance with Art 44 of the 2010 law.

The Sub-Fund may also enter into derivative contracts both for hedging purposes (typically forward agreements to hedge currency risks) as well as for investment purposes.

The Fund is actively managed and it has no reference benchmark.

The Sub-Fund has been categorized as a financial product falling under the scope of article 6 of the SFDR.

Redemption and Dealing Shares of the Fund may be redeemed on demand, with dealing normally on a daily basis.

Distribution Policy This Share Class does not pay dividends. Earned income is retained in the NAV.

Intended retail investor

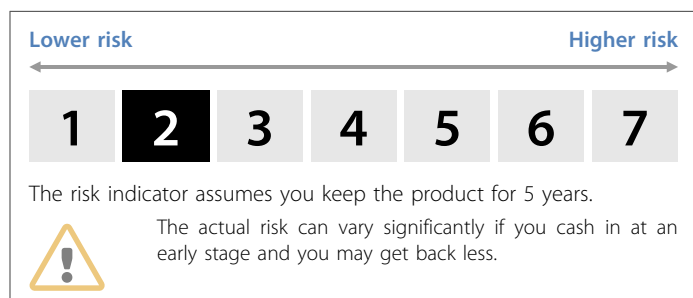
The fund has been designed for investors who are seeking income from a global and well diversified fixed income fund and who are comfortable with a certain amount of volatility. Due to specific nature or the fixed income market in term of rating, duration, capital structure and currency risk, the fund is suitable for investor who can afford to set aside the capital for at least a 5 years' investment horizon.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risks



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class.

This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact the capacity of the product to pay you.

WHAT HAPPENS IF PHARUS MANAGEMENT LUX S.A. IS UNABLE TO PAY OUT?

Pharus Management Lux S.A. is a société anonyme and has been appointed as management company of the Fund. The Fund is also a société anonyme and its assets are segregated from those of the Management Company. The Fund has entrusted the Depositary Bank with the safekeeping of its assets, which are kept separated from the Depositary Bank's assets. A default of Pharus Management Lux S.A. will therefore have no impact on the value of your investment in the product.

WHAT ARE THE COSTS?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,
- 10,000 EUR is invested.

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Recommended holding period: 5 years

Due to the nature of the investment strategy, the suggested holding period is at least 5 years. However the investors will be able to close their investments on each redemption date.

HOW CAN I COMPLAIN?

The purpose of the Complaints Handling Procedure of the Fund is to ensure that complaints are handled in a manner which is fair, objective and truth oriented. The following information shall be provided to ensure a prompt handling of the complaint:

- identity and contact details of the complainant;
- reason of the complaint; and
- where available, copies of any documentation supporting the complaint.

PHARUS MANAGEMENT LUX S.A. will send a written acknowledgement of receipt to the complainant within 10 working days after the receipt of the complaint, unless the answer itself is provided to the complainant within this period. PHARUS MANAGEMENT LUX S.A. shall seek to provide an answer to the complaint without undue delay and in any case within a period not exceeding 1 (one) month from the date of receipt of the complaint. If the answer cannot be provided within this period, PHARUS MANAGEMENT LUX S.A. will inform about the causes of the delay and the timescale to respond to the complaint.
